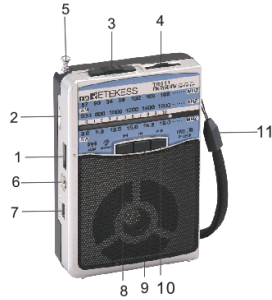

Function Operation:

1. USB slot
2. TF slot
3. Function and band button
4. Tuning button
5. Antenna
6. Earphone jack
7. Charge slot
8. The PREV button
9. The NEXT button
10. Play/Pause button
11. Hand strap

RADIO OPERATION:

1. Choose bands: tune band switch, can choose AM, FM, SW.
2. Turn the "TUNING" button to choose the required station.
3. Adjust antenna position to get the best receiving effect.

USB/TF OPERATION:

During radio program playing, insert USB/TF card, it will automatically switch to play from USB/TF card. You can press NEXT&PREV buttons or digital keys on radio to select the music you need.

NOKIA LITHIUM BATTERY

1. The unit NOKIA lithium battery, please note that first time need to charge 2hours.
2. Normally, if use lithium battery, it can operate unit in following time.
If use for USB/TF --- At a medium volume level, it can last Maximum 150minutes
If use for RADIO --- At a medium volume level, it can last Maximum 300minutes.

Local Government Regulations

When radios are used as a consequence of employment, the Local Government Regulations requires users to be fully aware of and able to control their exposure to meet occupational requirements.

Unauthorized modification and adjustment

Changes or modifications not expressly approved by the party responsible for compliance may void the user's authority granted by the local government radio management departments to operate this radio and should not be made. To comply with the corresponding requirements, transmitter adjustments should be made only by or under the supervision of a person certified as technically qualified to perform transmitter maintenance and repairs in the private land mobile and fixed services as certified by an organization representative of the user of those services. Replacement of any transmitter component (crystal, semiconductor, etc.) not authorized by the local government radio management departments equipment authorization for this radio could violate the rules.
